# **U.S. Federal Policy Update**

- A group of 117 House Democrats sent a <u>letter</u> to Speaker Nancy Pelosi (D-CA) and Democratic leadership – in which they urged the leaders to bring the Worker Relief and Security Act to the floor. The measure is a stand-alone bill that would extend unemployment benefits through the rest of the COVID-19 pandemic. However, Speaker Pelosi has spoken against bringing the individual measure to the floor – indicating that they are still focused on pushing forward a larger relief package. Meanwhile, Senate Republican leaders are still working to prepare a "skinny" \$500 billion measure, which includes: unemployment benefits, another round of Paycheck Protection Program loans, and other relief funding.
- The Defense Department <u>announced</u> \$17.4 million in Defense Production Act actions, which are aimed towards enhancing the domestic industrial base and to manufacturing products in response to COVID-19.
- The Department of State published an <u>updated fact sheet</u> on the United States' ongoing efforts to lead the global response and offer humanitarian assistance to the COVID-19 pandemic.
- The Centers for Disease Control and Prevention issued an updated guidance for schools, with more details for administrators on reopening schools and limiting the risks.

## **Global Response**

- World Health Organization Infectious Disease Specialist Dr. Maria Van Kerkhove stated that the WHO and UNICEF will issue a guidance next week on the use of facial coverings in children.
- Hong Kong Chief Executive Carrie Lam announced that their mass coronavirus testing program – which is going to be run on a voluntary basis – will begin on September 1<sup>st</sup>.

- Paraguay Health Minister Julio Mazzoleni announced that they will be implementing a "social quarantine" in order to restrict movement in the next two weeks.
- Officials from Beijing determined that residents would no longer be required to wear a mask in public, beginning this weekend.
- The Lebanese government implemented a curfew as of today, to start at 6 PM every evening and last until 6 AM every morning.

## State Update

- New Hampshire Governor Chris Sununu <u>announced</u> this afternoon that all of the state's restaurants are allowed to resume indoor dining at 100% capacity effective immediately.
- Hawaiian Governor David Ige signed an executive order that allows tourism to continue through a 14-day quarantine period to be allowed in a "resort bubble."
- The Dallas Independent School District announced that the school system will begin their academic year with fully remote learning when students return to school on September 8<sup>th</sup>.
- The Boston Public Health Commission announced that the city's public schools will begin their school year with completely remote learning starting September 21<sup>st</sup>. After this, they will use a phased approach to bring students back to the classroom.

## Economic Update

• U.S. stocks were on the rise today, with all three indices closing the day with increases. The Nasdaq Composite climbed by 0.42%, the S&P 500 by 0.34%, and the Dow Jones Industrial Average by 0.69%.
