ties in China. Being a member of the C9 League, China's equivalent of the Ivy League, USTC is under the direct leadership of the Chinese Academy of Sciences (CAS). USTC has taken a leading position among Chinese universities on the number of research papers published internationally and in the citation rate of the papers. In the past 4-5 years, several well recognized university rankings such as the QS World University Rankings and the US News & World Report Best Global Universities have consistently put USTC as a top-three research university in China and top 100 in the world.

With the great support and sponsorship from Lazaridis Institute, we continue to run the INFOMRS TIMES Best Dissertation Award this year. Two excellent emerging scholars in the field of innovation management and entrepreneurship have been identified as the finalists of this award. They will present their research at a special session scheduled on Monday, October 21st, 2019.

This year, we continue to run the INFORMS Best Working Paper Award. Professor Jochen Schlapp continues to be the coordinator of this initiative and did an excellent job in putting all pieces of work together. This competition provides another opportunity to our community members to showcase their best research and receive recognitions from our community. We continue to use a two-round

selection process and several finalist papers have been identified. As our new tradition, the final winner of this award will be announced by the judges at the TIMES Business Meeting on October 21st.

We also continue the tradition of selecting the most influential paper from the field of innovation management and entrepreneurship published at an INFORMS journal within the past five years. Through this initiative, we have connected with many prominent scholars from our field and listened to their insights about what good research is about. This award has created multiple benchmarks for newcomers to our field. This year, several papers have been identified as finalists and the winning paper will be announced at the TIMES Business meeting on October 21st.

In the past two years, Professor Ashish Arora and Professor Moren Levesque voluntarily served the role of Honorary Chairs of TIMES and provided a lot of insightful advice regarding the strategic direction of TIMES. In addition, they provided great supports to the newly launched Best Working Paper Award competition by being the judges and selecting/evaluating the paper at the second round. Professor Vish Krishnan is a Chaired Professor and the Faculty Director of Rady's Entrepreneurship Initiative, CIID. One of the Rady School's founding faculty bringing deep start-up/business experience in California and Texas, Professor Krishnan has developed unparalleled expertise in researching and teaching innovation, entrepreneurship, and product management. He is an accomplished scholar and world-renowned consultant who has worked with the senior leadership at companies such as Nissan, Zeiss, Amylin Pharma, Motorola, and Sony on organizational, cultural, and digital transformation. His work with Dell Computer and other companies has been documented as a Harvard Business School case study and taught at a number of top universities. His work with 3M resulted in an appearance on the front page of the Wall Street Journal. Professor Krishnan worked with Nissan and Sony on the transformation and growth of their international businesses, including India and South Asia.

In his research, Professor Krishnan works on improv-

ing the effectiveness and efficiency of innovative operations and ventures, and collaborates closely with the School of Medicine through grants from the National Institute of Health and the State of California. He has been a founding member of start-up teams and is an advisor to a number of startup teams and major international companies.

Professor Krishnan has led Rady School's signature core course series, Lab to Market, which allows Rady students the opportunity to gain hands-on experience in entrepreneurship by developing their own businesses. In addition, Professor Krishnan also serves as the Associate Director for the Institute for the Global Entrepreneur, a joint venture between the Rady School and the Jacobs School of Engineering – where he holds a joint appointment.

Professor Krishnan serves in the editorial positions of elite academic journals in the areas of innovation, entrepreneurship, and product/operations management. He is a Distinguished Fellow of the College of Innovation and Technology Management Production and Operations Management Society. He has been named the Most Valuable Professor by Rady Students four times during the last decade and has been invited to teach at MIT and Harvard University.

Daniel Blaseg

(Goethe University ESADE Business School, Bernd Skiera)

Daniel Blaseg is an Assistant Professor of Entrepreneurship at the ESADE Business School in Barcelona. He received his Ph.D. in quantitative marketing from the Goethe University Frankfurt (Germany) and holds master's degrees in law (LL.M.) and finance (M.Sc.). Daniel's primary research interests lie at the intersection of entrepreneurship, finance, and marketing. A particular focus concerns the economics and regulation of alternative sources of entrepreneurial finance such as crowdfunding. For example, he aims to provide insights into the outcomes of crowdfunding, specifically whether entrepreneurs deliver on their promises and how entrepreneurs perform after the campaign. Moreover, as outcomes are often determined by initial conditions, he investigates the determinants and contexts of using crowdfunding. Before entering academia, Daniel gained practical experience as a consultant for venture capital transactions and start-up acquisitions at a leading corporate finance boutique in Germany and as co-founder and CFO of several start-ups.



Evgeny Kagan

(University of Michigan Ross School of Business, Stephen Leider and William Lovejo)

Evgeny is an assistant professor of Operations Management and Business Analytics at the Johns Hopkins Carey Business School. Evgeny's research examines operational questions in innovation, product development and entrepreneurship. These include incentive design and contracting in start-up teams, product development as well as entrepreneurial market identification. His research has been published in leading journals, such as Management Science, and he is a recipient of several research awards. Evgeny is also a co-author on a report commissioned by the Kauffman foundation studying entrepreneurial mentoring. He has helped develop the new Business Analytics course at the Carey school, and is the course lead of that course. He received his BS degree from the University of Mannheim, MS degree from the Rotterdam School of Management, and PhD degree from the University of Michigan, Ross School of Business.

2019 TIMES Distinguished Service Award

The INFORMS TIMES Distinguished Service Award is set up to acknowledge the past TIMES officers or community members who contributed extraordinary services and long-term commitment to the INFORMS community of Technology, Innovation Management and Entrepreneurship area. The past winners of this award include Professor Juliana Hsuan (2018), Professor John Angelis (2018), Professor Cheryl Gaimon (2009) and Professor Jeffrey Liker (2004).

This year, the TIMES chair, Professor Zhijian Cui, has nominated two candidates for this year's INFORMS TIMES Distinguished Service Award:

- · Professor Ashish Arora from Duke University
- · Professor Moren Levesque from York University

Professor Ashish Arora is the Rex D. Adams Professor of Business Administration and Senior Associate Dean of Faculty at the Fugua School of Business at Duke University. His research focuses on the economics of technology and technical change. His research has included the study of technology intensive industries such as software, biotechnology and chemicals, the economics of information security, and the role of patents and licensing in promoting technology start-ups. He has studied the rise of the software industry and the pharmaceutical industry in emerging economies. His current research focuses on the management of intellectual property and licensing in corporations, and innovation based entrepreneurship. Ashish has taught a variety of courses, including Economics of Information Security and Risk Management. He currently teaches Entrepreneurial Strategy for Innovation Based Ventures, and Emerging Markets Strategy.



Ashish serves as departmental editor of *Management Science*, served as an editor of *Research Policy* between 2008 - 2014, and is on the editorial board of *Strategic Management Journal, Research Policy, Industrial and Corporate Change, Information Economics and Policy, Journal of Evolutionary Economics.* In the past, he has served on advisory panels to the Secretary of Commerce, the National Academy of Sciences, and The Association for Computing Machinery.

Ashish has served role of Honorary Chair of TIMES from 2017 to 2019. At this position, he provided a lot of guidance and advice related with the development of TIMES community. In addition, he has been the Judge for the INFORMS TIMES Best Working Paper Award for two consecutive years from 2017 to 2019. On his editorial position at *Management Science*, Ashish also made prominent contributions to improve the impact of Innovation Management and Entrepreneurship Department. At his deanship po-

sition, he also promoted the fast growth of innovation community.

Professor Moren Levesque is Professor and the CPA Ontario Chair in International Entrepreneurship at York University Schulich School of Business, and a Lazaridis Visiting Chair at Wilfrid Laurier University Lazaridis Institute for the Management of Technology Enterprises. Her research applies the methodologies of analytical and quantitative disciplines to the study of decision making in new business formation. She is interested in market entry decisions, funding decisions, and firm growth decisions, and the impact of time on these entrepreneurial decisions. Her work appears in Entrepreneurship Theory & Practice, European Journal of Operational Research, IEEE Transactions on Engineering Management, Journal of Business Venturing, Journal of Management Studies, Long Range Planning, Manufacturing & Service Operations Management, Organization Science, Production and Operations Management, Strategic Entrepreneurship Journal and Strategic Management Journal, among other research outlets.

Moren has served the Academy of Management's Entrepreneurship Division as a member of its Research Committee and its Midwest Regional Liaison, as well as Chair of its Membership Committee. She currently also serves as Editor for *Entrepreneurship Theory & Practice*, Senior Editor for *Production and Operations Management*, and she served from 2013 to 2017 as Department Editor for *IEEE Transactions on Engineering Management*.



Moren has also served for a 5-year term as an officer for the Institute for Operations Research & Management Science (INFORMS) Technology, Innovation Management and Entrepreneurship Section (TIMES), and currently serves as a TIMES Honorary Chair. At this position, she provided a lot of guidance and advice related with the development of TIMES community. She has also been the Judge for the INFORMS TIMES Best Working Award for two consecutive years from 2017 to 2019. Moren is not only an excellent researchers but also a great teacher disseminating the know-how of entrepreneurship. She is the Co-Director of Entrepreneurial Studies program with an aim of developing the entrepreneurship programs at the Schulich School of Business, York University in Canada.


