


THE MIF UPDATE

Member's Spotlight

Michelle M. Alvarado received her BS in industrial engineering (2008) from the University of Alabama. She received her ME and PhD in industrial engineering (2010, 2014) from Texas A&M University. She was also a postdoctoral research scholar (2015) and visiting assistant professor (2016-2017) in industrial engineering at Texas A&M University, before joining the University of Florida as an assistant professor in industrial engineering in 2017. Dr. Alvarado is the Co-Founder and Co-Director of the HEALTH-Engine Laboratory, where she develops theory, models, algorithms, and practical tools to enhance the operation of complex systems under

uncertainty, particularly in healthcare systems engineering. Her research focuses on integrated simulation and optimization methods, with a particular interest in stochastic programming and hybrid simulation modeling. Dr. Alvarado's research applications include health policy modeling for hospital readmissions and health insurance decision-making, appointment scheduling, and simulation modeling for outpatient clinics and population health. Her research has been funded by the NIH and the UF Foundation, among others.

Dr. Alvarado joined the INFORMS Minority Issues Forum (MIF) in 2012. She received the INFORMS Judith Liebman Award in 2014, won the MIF paper competition in 2017, and was a MIF Early Career Award Finalist in 2022. Dr. Alvarado has served as the secretary of the MIF Board since 2020.

MIF Fellows

The MIF Fellow Award is given to recognize the sustained contributions of individuals to the forum's activities and increase the participation of underrepresented minorities in the OR/MS community. To nominate an active MIF member, the <u>MIF Fellow Nomination Form</u> should be completed and sent via email to the MIF President, Eduardo Perez (<u>eduardopr@txstate.edu</u>), by August 1, 2023.

Early Career Award

This award recognizes outstanding contributions to the theory or practice of OR/MS *and* service made by early career, active members of MIF. The award recognizes exceptional researchers who have shown promise early in their academic or industrial career. Scholars who are pre-tenure and within 8 years of receiving their doctorate (or equivalent) degree are eligible to apply. The topic of the nomination and the underlying work must be related to the field of OR/MS. Applicants should submit the following documents:

- 1. Recent CV
- 2. Two short statements summarizing the applicant's:
 - Research interests, contributions, and future work (one page)
 - Service contributions with a focus on underrepresented minorities in OR/MS (one page)
- 3. A statement indicating how long the applicant has been a member of MIF
- 4. At least one letter of recommendation

Applications are due by **June 16th** at 11:59pm EDT and should be e-mailed as a single pdf with the subject line: "*MIF Early Career Award Nomination*" to the chair of the prize committee, David A. Nembhard: <u>david-nembhard@uiowa.edu</u> (please also cc: <u>mif.informs@gmail.com</u>). Finalists will be announced by July 31st.

Paper Competition

We invite submissions for our 8th annual paper competition. Submissions for the competition will be accepted through **May 25, 2023** and should satisfy the following criteria:

- The paper must have been accepted or published on or after **January 1**, **2021** in a research outlet in the field of operations research, management science, or information systems. There are no restrictions on the topic of the paper.
- The lead author must be a **current INFORMS MIF member** at the time of submission. MIF considers the lead author to be the first author or the corresponding author.
- The paper must be written in English.
- Submissions should be mailed to the INFORMS MIF email address (<u>mif.informs@gmail.com</u>) and should include:
 - \circ $\,$ Name, affiliation, and contact information for the corresponding author $\,$
 - Bibliographic reference and a PDF file of the paper
 - A cover letter that describes the relative contributions of each author of the paper, as well as the impact of the paper within its respective theoretical field and/or application area
