All faculty levels will be considered, but candidates should expect to have completed their doctoral degree by September 1, 2019. We seek candidates who have an active program of research and demonstrated teaching excellence in information systems. Chosen candidates will be expected to conduct research, teach, and perform service in this area. Preference will be given to candidates with specialization in the areas of business analytics, artificial intelligence, and data-driven management. Candidates who can mentor students from underrepresented populations are strongly encouraged to apply. Salary is competitive and commensurate with rank and experience.
